The manufacturer or supplier must apply for an extension of the approval in writing. The application must contain confirmation that the formulation is unchanged. In the case of rebrands a written declaration of consent from the previous supplier must be submitted as well.

After expiry of the approval period the product approval can be continued only by way of a new approval procedure, for which a charge will be made.
